## CORPORATE HIRE AGREEMENT Terms and Conditions of Hire

1. It is the responsibility of the event organizer/hirer to ensure that there is **EASY ACCESS** into the venue for the unloading AND re-loading of the equipment. Also, to ensure that, if required by Krazy Kidz (Softplay) Limited, parking facilities are available.
2. If the venue is not on the ground floor, easy access to a lift is required. In the event of no available lift service, a surcharge subject to negotiation would apply. Krazy Kidz (Softplay) Limited reserve the right to refuse a venue if the loading/unloading facilities are not as originally described, this would result in cancellation of the contract and forfeiture of all monies paid.
3. If required, Krazy Kidz (Softplay) Limited can stay at the venue to supervise, at extra cost.. It is the responsibility of the event organizer/hirer to ensure there is adequate supervision according to the number of children attending.
4. It is the responsibility of the hirer to ensure that all possible steps are taken to avoid injury.
5. It is the responsibility of the hirer to ensure that, once set-up, due care and attention is given to avoid damage to the softplay equipment.
6. In the event of inclement weather the full fee is still recoverable. Krazy Kidz (Softplay) Limited advise considering covered venues or contingency planning. We will of course do all we can to assist where possible.
7. Delivery Charges are subject to venue location.
8. Krazy Kidz (Softplay) Limited will endeavour to arrive in plenty of time to set up and to collect, however, Krazy Kidz (Softplay) Limited are not responsible for any delay incurred through unforeseen circumstances, ie traffic problems, bad weather etc.
9. Individual payment as agreed for each booking.
10. Any changes to the original booking must be received in writing. Alterations are only valid if agreed by us in writing.
11. All prices are subject to change at any time. Exclusions include confirmed bookings.
12. Krazy Kidz (Softplay) Limited reserve the right to charge a cancellation fee as follows, based on the full contract value:-  
30 days+ - 0  
15-29 days – 75%  
8-14 days – 50%  
7 days or less – 100%
13. Any damage to equipment, including accessories, must be reported to Krazy Kidz (Softplay) Limited as soon as possible.
14. Krazy Kidz (Softplay) Limited reserve the right to charge an additional fee if items are damaged.

## Terms and Conditions of Hire

### RULES OF PLAY

- 1.. When using the Ball Pond, Krazy Kidz (Softplay) Limited request that the attendant/supervisor does not allow the balls to be thrown or kicked far from the softplay area as this will result in a delay of collection and leaving the venue.
- 2.. Socks **MUST** be worn during play.
- 3.. No food, drink, or chewing gum to be allowed on or near the softplay equipment.
- 4.. All shoes, glasses and jewellery **MUST** be removed before play can begin.
- 5.. No face paints or other coloured objects like silly string to be allowed near the softplay equipment.
- 6.. A NO SMOKING policy applies on and around the softplay equipment.
- 7.. Ensure that children are not causing distress to others by pushing, shoving or fighting whilst using the play equipment.
- 8.. Do not allow unwell children to use any of the softplay equipment.
- 9.. No animals or sharp objects to be allowed near the softplay equipment.
- 10.. If being used outside, please ensure that the supplied ground sheet is under the softplay equipment and matting at all times.
- 11.. The hirer is expected to use due care during use.
- 12.. Equipment must be returned in the same state it was delivered in.
